1. G-Vision Bathware, Inc. is a manufacturer and wholesale distributor of AquaEze™ brand Walk-In bathtubs. All sales transactions that occur are solely between the authorized AquaEze™ dealer and G-Vision Bathware, Inc. There are no retail operations within G-Vision Bathware, Inc., this effectively means that when any consumer calls us, we then automatically refer them to their nearest authorized AquaEze™ dealer.
2. All dealers, after applying may then be authorized to sell AquaEze™ brand products, all authorized dealers are pre-pay accounts by default that means that your order will be shipped after payment is received. Dealers that have been verified through credit references and banking information, may receive individual credit limits set by G-Vision Bathware, Inc. at our digression, and subject to change without notice.
3. All AquaEze™ brand Walk-In tubs are offered with the original factory warranty as described in the AquaEze™ owner's manual. However, the factory warranty will be automatically null and void if any of the following situations occur:
  - a. Any AquaEze™ Walk-In tub is being or has been used solely for display purposes.
  - b. Any AquaEze™ Walk-In tub which has been modified in any form which differs from the shipment of the original unit shipped from the factory. **Example:** By adding water or air jets to the AquaEze™ soaking tubs by anyone including, but not limited to the dealer, plumber, or contractor is a major modification to the original factory shipped soaking unit.
  - c. Any unit which has been used and/or re-sold as new.
  - d. Any unit that changes ownership after being installed. The expressed warranty is valid only to the original homeowner upon warranty registration.
  - e. Any AquaEze™ Walk-In tubs purchased at special closeout rates.
  - f. Any Unit which has not been registered via warranty registration cards provided with G-Vision Bathware, Inc. products, or via phone-in registration by calling:

4. G-Vision Bathware, Inc. reserves the right not to deal directly with the consumer if the AquaEze™ warranty has been deemed null and void for any of the reasons stated in paragraph 3 items a-f.
5. All AquaEze™ Brand Wholesale pricing is FOB Lecanto, Florida. The Dealer is responsible to arrange shipping and all the freight costs incurred. G-Vision Bathware, Inc. will gladly assist and recommend low cost carriers if you don't have one. We highly recommend insuring goods for their full value. G-Vision Bathware, Inc. safely packages all of our products in an effort to prevent shipping damage. The receiver of the goods is responsible to check for and report immediately any damage which has occurred during transit.
6. All AquaEze™ products are stringently tested and inspected by our qualified quality control staff before being released for shipment. Unless it is a factory defective or the incorrect product has been shipped, all shipped orders are final.
7. Upon receipt, if your product is suspect to being factory defective or deemed to be the wrong item, requests for returns and/or exchanges must be made in writing, within 5 days and include any pictures, and documentation to such claims. The return freight is the dealer's responsibility by default. G-Vision Bathware, Inc. will authorize the acceptance of the return goods in original condition and packaging at the factory located in Lecanto, Florida, at which time the returned goods will be fully evaluated for such claims.
  - a. If it determined that it indeed was a factory defect, G-vision will fully credit back the goods cost, plus the round trip freight cost.
  - b. If it is determined that the product(s) are in fact is not defective. An industry standard re-stocking fee of 20% + all shipping charges will be deducted from the moneys previously collected and the balance will be refunded.
